Release of Lien on Trademarks

WHEREAS, the Assignor entered into those certain Trademark Security Agreements dated as of July 2, 2008, November 26, 2010 and August 18, 2011 (the “**Agreements**”) with the Assignee to evidence its grant of a security interest in the trademarks set forth on Schedule A hereto;

WHEREAS, the Agreements relating to the trademarks were recorded with the United States Patent and Trademark Office on August 20, 2008 on reel 3838 frame 0348, December 9, 2010 on reel 4429 frame 0099 and August 18, 2011 on reel 4607 frame 0161;

WHEREAS, the Assignee desires to release its security interest in and lien on the trademark set forth on Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignee does hereby release its security interest in and lien on the trademark set forth on Schedule A hereto and reassigns to the Assignor all right, title and interest of the Assignee in and to such trademark.
