CERTIFICATE OF AMENDMENT

OF

CERTIFICATE OF INCORPORATION

OF

IOP FILTER, INC.

The undersigned being the Secretary of IOP Filter, Inc., a Delaware corporation (the "Corporation"), for the purpose of amending the Certificate of Incorporation of the Corporation under the General Corporation Law of the State of Delaware, hereby certifies:

FIRST: The name of the Corporation is IOP Filter, Inc.

SECOND: In accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware, the sole director and the sole stockholder of the Corporation adopted the following amendment to the Certificate of Incorporation, declaring said amendment advisable:

The Certificate of Incorporation of the Corporation is hereby amended to change the name of the Corporation by striking Article I of the Certificate of Incorporation in its entirety and inserting the following:

"One: The name of the Corporation is Kuss Filtration Inc."

THIRD: This amendment shall become effective upon filing.
