ASSIGNOR hereby sells, assigns and transfers to ASSIGNEE, its successors and assigns, said ASSIGNOR'S entire right, title and interest in, to and under the Intellectual Property, including, without limitation, (i) all United States and foreign rights therein, whether protected by copyrights or not, whether patentable or not, and in and to aforesaid registrations, patents, patent applications and any divisions or continuations thereof, and any patents or other registrations obtained for the Intellectual Property in the United States and any foreign countries, or issuing out of said applications or any such division or continuation thereof, and any reissues or extensions of any such patents or copyrights and (ii) all works of authorship associated therewith.

ASSIGNOR hereby authorizes and requests the Commissioner of Patents of the United States, the United States Copyright Office and any official of any country or countries foreign to the United States, whose duty it is to issue patents, copyright registrations or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.
