NUNC PRO TUNC TRADEMARK ASSIGNMENT

This NUNC PRO TUNC TRADEMARK ASSIGNMENT ("Assignment") is executed May 23, 2012, and is effective as of February 5, 2010 ("Date of Assignment"), by JT SPORTS LLC, a Delaware limited liability company ("Assignor"), to KEE ACTION SPORTS, LLC, a Delaware limited liability company ("Assignee").

WHEREAS, prior to February 5, 2010, Assignor owned the entire right, title and interest in and to the trademarks and trademark registrations identified on Schedule A attached hereto for the identified goods as listed in Schedule A (collectively, the "Marks"), together with the goodwill of the business symbolized thereby and associated therewith;

WHEREAS, on February 5, 2010, pursuant to that certain Asset Purchase Agreement between Assignor and Assignee dated February 5, 2010, Assignor did assign to Assignee, *inter alia*, all right, title and interest in and to the Marks as they relate to the business of designing, manufacturing, selling and distributing paintballs, paintball markers, paintball loaders, paintball masks, paintball accessories and/or other products that are specifically designed for the paintball industry and airsoft guns and/or other products that are specifically designed for the airsoft industry (the "Assigned Business"), together with the goodwill of the Assigned Business symbolized thereby and associated therewith;

WHEREAS, Assignor and Assignee are desirous of dividing the trademark registrations identified in Schedule A between them, with that part of the trademark registrations relating to the Assigned Business to be owned by KEE for "KEE's Goods" as identified in Schedule B; and with Assignor retaining ownership of the Marks for "JT's Goods" as identified in Schedule B for other than the Assigned Business; and,

WHEREAS, Assignor and Assignee are desirous of making the Assignment of the Marks as they relate to the Assigned Business, for KEE's Goods as shown in Schedule B, a matter of record in the U.S. Patent and Trademark Office.

NOW, THEREFORE, in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be

legally bound, Assignor hereby acknowledges that it did, on February 5, 2010, sell, assign, transfer and set over to Assignee, its successors, legal representatives and assigns, the entire right, title, and interest of Assignor in and to said Marks as they relate to the Assigned Business, including for KEE's Goods as shown in Schedule B, together with the goodwill of the Assigned Business symbolized thereby and associated therewith.

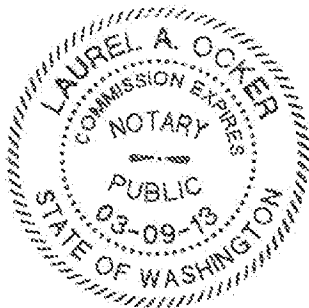
