

## TRADEMARK COLLATERAL ASSIGNMENT

This Trademark Collateral Assignment ("Collateral Assignment") is executed this 23rd day of May, 2012 by Eades Appliance Technology, LLC, a Nevada limited liability company ("Assignor"), in favor of JSW Lending, Inc., a Nevada corporation ("Assignee").

### WITNESSTH:

WHEREAS, Assignor has adopted, used and is using, and is the owner of the entire right, title, and interest in and to the Trademarks and applications therefore which are described in Exhibit A attached hereto (the "Trademarks"); and

WHEREAS, Assignee has agreed to lend to Assignor certain funds as evidenced by a certain Promissory Note of even date herewith (the "Note") executed by Assignor in favor of Assignee, and Assignor has agreed to borrow such funds from Assignee; and

WHEREAS, in order to secure the prompt and complete payment and performance of the Assignee's obligations, representations and warranties under the Note and Security Agreement (the "Secured Obligations"), and pursuant to the terms of a certain Security Agreement of even date herewith entered into by Assignor in favor of Assignee (the "Security Agreement"), the Assignor has agreed to grant Assignee a security interest in and continuing lien on all of Assignee's right, title and interest in the Trademarks.

NOW, THEREFORE, in consideration of the premises and the agreements, provisions and covenants herein contained, the parties hereto agree as follows:

1. Grant of Security Interest. As collateral security for the prompt and complete payment and performance of all of the Secured Obligations, Assignor hereby assigns, transfers, conveys and grants a security interest and mortgage to Assignee, in and to Assignor's entire right, title and interest in, to and under the Trademarks.

2. Authorization and Request for Recordation. Assignor hereby authorizes and requests that the United States Commissioner of Trademarks and Trademarks or any other applicable United States government or state government officer record this Agreement.

3. Security for Obligations. Assignor hereby acknowledges and affirms that this Collateral Assignment secures, and the Trademarks are security for, the prompt and complete payment or performance in full when due, whether at stated maturity, by required prepayment, declaration, acceleration, demand or otherwise of all the Secured Obligations.

4. Security Agreement. The Assignor acknowledges and confirms that the rights and remedies of Assignee with respect to the collateral assignment of and security

interests in the Trademarks acknowledged and confirmed hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated herein by reference. In the event of any irreconcilable conflict between the terms of this Collateral Assignment and the terms of the Security Agreement, the terms of the Security Agreement shall control.

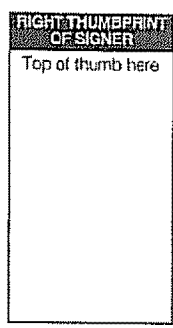

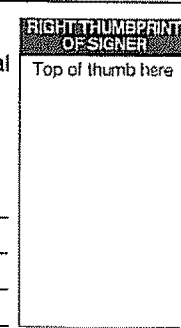
