**DECLARATION OF LINDA G. HENRY IN SUPPORT OF
CORRECTIVE ASSIGNMENT**

I, Linda G. Henry, declare as follows:

1. I am an attorney at law admitted to practice in the courts of the State of California. I am Senior Counsel in the law firm of Fenwick & West LLP, counsel for NEXCURA, LLC. I submit this declaration in support of the Corrective Assignment to correct the previously recorded assignment against the following two U.S. Trademark Registrations:

I have reviewed the information and documents on the United States Patent and Trademark Office's (the "Office") publically available online databases for U.S. Trademark Registration Nos. 2543563 and 2810512 (the "Registrations"), including documents recorded with the Assignment Recordation Branch available via the Trademark Assignment Details web pages. I make the following statements based upon my own personal knowledge of such review and, if called as a witness, I could and would testify competently to the facts set forth herein.

2. The Office's database information for the Registrations show that the Registrations originally issued to Nexcura, Inc.

3. Further, the Office's database information for the Registrations show the last listed owner for the Registrations as PDR Network, LLC, a Delaware limited liability company, c/o Lee Equity Partners, LLC, 650 Madison, 21st Floor, New York, New York 10022.

4. However, based on my review of the documents recorded against the Registrations, the true owner of the Registrations is NEXCURA, LLC, a Delaware limited liability company, c/o Lee Equity Partners, LLC, 650 Madison, 21st Floor, New York, New York 10022.

5. Below is a timeline summary of the changes of ownership for the Registrations based on the documents recorded against the Registrations:

December 26, 2006 - Nexcura, Inc. merged with and into Thomson Healthcare Inc.
Reel/Frame 3463/0518

December 14, 2007 - Thomson Healthcare Inc. changed its name to Physicians' Desk Reference Inc. Reel/Frame 3751/0653

September 1, 2009 - Physicians' Desk Reference Inc. assigned the Registrations to PDR Acquisition, LLC. Reel/Frame 4057/0938

September 1, 2009 - PDR Acquisition, LLC assigned the Registrations to NEXCURA, LLC. Reel/Frame 4059/0524


September 9, 2009 - PDR Acquisition, LLC changed its name to PDR Network, LLC.
Reel/Frame 4059/0543

6. The Change of Name document at Reel/Frame 4059/0543 showing that PDR Acquisition, LLC changed its name to PDR Network, LLC on September 9, 2009 should not have been recorded against the Registrations. Based on the conveyance recorded at Reel/Frame 4059/0524, PDR Acquisition, LLC no longer owned the Registrations at the time that it changed its name. Instead, PDR Acquisition, LLC had already assigned the Registrations to NEXCURA,

LLC as of September 1, 2009. Therefore, the September 9, 2009 change of name from PDR Acquisition, LLC to PDR Network, LLC should not have been recorded against the Registrations.

7. Based on the documents recorded against the Registrations, the true owner of the Registrations is NEXCURA, LLC, a Delaware limited liability company. Because the change of name at Reel/Frame 4059/0543 should not have been recorded against the Registrations, the true owner of the Registrations is NEXCURA, LLC, a Delaware limited liability company.
