RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE is made as of May 23, 2012 by SUNTRUST BANK, as Administrative Agent ("**Secured Party**").

WITNESSETH:

WHEREAS, pursuant to that certain Grant of Security Interest Patent and Trademarks dated as of January 20, 2010 (the "**Security Agreement**"), by and between United Feature Syndicate, Inc., a New York corporation (the "**Grantor**") and Secured Party, the Grantor granted a security interest to the Secured Party in certain Trademarks (as defined in the Security Agreement), including the Trademarks set forth on Exhibit A hereto (the "**Specified Trademarks**"); and

WHEREAS, the Secured Party has been requested to release its rights in the Specified Trademarks and to re-convey to Grantor any and all rights in and to the Specified Trademarks.

NOW THEREFORE, in consideration for the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby terminates, releases and discharges its security interest in and to all of Grantor's right, title and interest in and to the Specified Trademarks originally granted to Secured Party pursuant to the Security Agreement.
2. Secured Party, to the extent granted in the Security Agreement, hereby assigns, grants and otherwise re-conveys to Grantor, without any representation, recourse or undertaking by Secured Party, any and all of its right, title and interest in and to the Specified Trademarks and all goodwill associated therewith originally granted to Secured Party pursuant to the Security Agreement.
3. Upon the request of Grantor, Secured Party further agrees to execute all documents necessary to demonstrate and confirm the parties' intent under this Release of Trademark Security Interest.

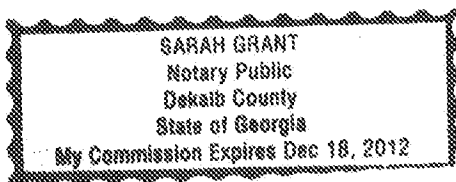
