THIS ASSIGNMENT is made this 24th day of May, 2012.

BETWEEN

1. GUANGDONG CANNERY whose registered office is situated at SIHENG ROAD, YUANCUN, GUANGZHOU, GUANGDONG, CHINA (hereinafter referred to as “the Assignor”); and
2. GUANGZHOU LIGHT INDUSTRY & TRADE GROUP LTD whose registered office is situated at NO. 147, YANJIANG XI ROAD, GUANGZHOU, P.R.CHINA (hereinafter referred to as “the Assignee”).

WHEREAS

The Assignor is the legal and beneficial owner of the Trade Mark “” under Reg. No. 2833914 at the United States Patent and Trademark Office, particulars of which are set out in the Schedule (hereinafter referred to as “the Trade Mark”).

By an agreement made between the parties on May 24th, 2012 the Assignor agreed to assign the Trade Mark to the Assignee on the terms set out therein and to execute this assignment.

IT IS HEREBY AGREED as follows:

1. In pursuance of the said agreement and in consideration of the sum of USD 1.00 paid by the Assignee to Assignor the Assignor hereby ASSIGNS and transfers all right title and interest in the Trade Mark, including all statutory and legitimate rights attaching hereto and the right to sue for pass infringements and to retain any damages obtained as a result of such action, to the Assignee.
2. The Assignor confirms that this assignment is made with the goodwill attaching to the Trade Mark.
3. The Assignor warrants to the Assignee as follows in respect of the Trade Mark:-
 - 3.1 that all renewal fees due in respect of the registrations have been paid;

3.2 that the Assignor has appointed no licensee of the Trade Mark nor given any other person any permission to use the Trade Mark;

3.3 that the Assignor is unaware of any infringement of the registration of the Trade Mark or of any reason why any registration may be capable of being expunged from the register for any reason whatsoever;

3.4 that there are no circumstances known to the Assignor arising out of this which may result in the use of the Trade Mark being liable to mislead the public;

3.5 that there is no previous assignment of the Trade Mark, and that the Assignor is properly entered on the Register of Trade Mark as proprietor of the registration.

4. The Assignor warrants to the Assignee in respect of Trade Mark as follows :-

4.1 that the Assignor has given no permission to any third party to use the Trade Mark;

4.2 that the Assignor is unaware of any use by any third party of the Trade Mark assigned or any mark similar in connection with the goods in respect of which the Assignor has used them;

4.3 that the Assignor has not made any other assignment or purported assignment of the same or similar marks used in relation to the same or similar goods in respect of which the Trade Mark has been registered.

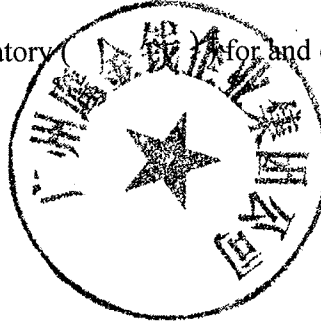

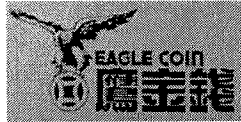
