## RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, by that certain Amended and Restated Contingent Patent, Trademark and License Assignment dated as of November 30, 1999 ("1999 Assignment"), recorded in the Trademark Assignment database of the United States Patent and Trademark Office ("PTO") on August 1, 2003 at Reel/Frame 2787/0283 and corrected on April 23, 2004 at Reel/Frame 2833/0635, The Tranzonic Companies ("Grantor") granted to PNC Bank, National Association as successor-by-merger to National City Bank, a national banking association of the United States of America ("Releasor"), a pledge of trademarks pursuant to the Credit and Security Agreement dated February 5, 1998, as amended and restated by the amended and restated Credit and Security Agreement of even date therewith ("1999 Trademark Collateral"), including without limitation the trademark applications and registrations identified in Schedule I;

WHEREAS, by that certain Contingent Patent, Trademark and License Assignment dated as of March 26, 2010 ("2010 Assignment"), recorded in the Trademark Assignment database of the United States Patent and Trademark Office ("PTO") on April 1, 2010 at Reel/Frame 4178/0157, Grantor granted to Releasor, a pledge of trademarks pursuant to the Credit and Security Agreement dated March 26, 2010, ("2010 Trademark Collateral"), including without limitation the trademark applications and registrations identified in Schedule II;

WHEREAS, Releasor wishes to release, relinquish and discharge its security interest in certain portions of the 1999 Trademark Collateral and 2010 Trademark Collateral and provide a document suitable for recording in the Trademark Assignment Database of the PTO for purposes of recording the release, relinquishment and discharge of its security interest in those certain portions of the 1999 Trademark Collateral and the 2010 Trademark Collateral;

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby relinquishes, releases and discharges the security interest in the trademarks listed in Schedule I and Schedule II granted by Grantor in the Credit and Security Agreement dated February 5, 1998, as amended and updated and the Credit and Security Agreement dated March 26, 2010.

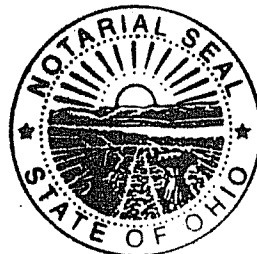
