RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is given as of this 31st day of May 2012 by RBS Citizens, National Association ("Assignor") in favor of White Rock Distilleries, Inc., a Maine corporation ("Assignee").

WHEREAS, pursuant to a Credit Agreement dated September 9, 2008, as amended on August 31, 2009, and a Trademark Security Agreement dated September 9, 2008, Assignee granted, assigned and conveyed to Assignor a security interest in certain Trademarks (which, for clarity, are set forth on Schedule A) and the goodwill of the business symbolized by the Trademarks (collectively, the "Trademark Collateral") and the Trademark Security Agreement was recorded with the U.S. Patent & Trademark Office ("PTO") on September 11, 2008 at Reel/Frame 3850/0510, et seq;

WHEREAS, Assignee's debt has been paid in full and all security interests in the Trademark Collateral have been terminated; and

WHEREAS, the parties desire to confirm the release of all security interests which had been granted in favor of Assignor in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

Assignor hereby terminates, releases and discharges fully its security interest in the Trademark Collateral.

Assignor hereby authorizes Assignee or Assignee's authorized representative to (i) record this Release with the PTO, (ii) file UCC Financing Statement Amendments with the applicable filing office in order to memorialize the release of any security interest of Assignor in the Trademark Collateral, and/or (iii) otherwise file this Release.

Assignor further agrees to execute and deliver to Assignee any and all further documents and instruments and do any and all further acts which Assignee (or its agents or designees) reasonably requests in order to confirm this Release and Assignee's right, title, and interest in and to the Trademark Collateral, including, but not limited to, the Trademarks set forth on Schedule A.
