On December 10, 2007 an Assignment document was recorded with the U.S. Patent and Trademark Office under Reel/Frame: 3675/0195 to change ownership of the above registration from Hunting World LLC to Itochu Corporation. Because the Assignment was incorrect with respect to the state of incorporation of Hunting World LLC, we request correction of the corporate information on record.

The original owner of this registration was Hunting World LLC. Although its main office was located in the state of Nevada, at the time of the assignment, Hunting World LLC was a Delaware corporation. 

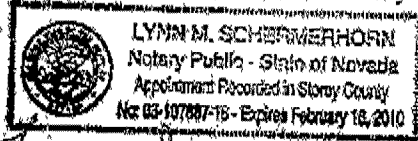
