CONFIRMATORY TRADEMARK ASSIGNMENT

WHEREAS the parties hereby desire to reconfirm the prior assignment of the **Assigned Trademark**, the United States application therefor, and goodwill of **Assignor** associated therewith, in order to record the change of the ownership in the Assignment Division of the Patent and Trademark Office and place formal title in the name of **Assignee**.

NOW, THEREFORE, for good and valuable consideration, previously paid by **Assignee** to **Assignor**, the receipt of which is hereby acknowledged, **Assignor** does hereby sell, assign, set over and transfer unto said **Assignee**, nunc pro tunc, as of November 10, 2011, all right, title and interest in and to the **Assigned Trademark** and the above-identified United States application therefor, together with the whole of the goodwill of the business symbolized by the **Assigned Trademark**, the same to be held and enjoyed by the **Assignee** for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the **Assignor** if this assignment and sale had not been made; together with all claims for damages by reason of past infringement of the **Assigned Trademark**, and with the right to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns or other legal representatives.
