TRADEMARK ASSIGNMENT NUNC PRO TUNC

This TRADEMARK ASSIGNMENT NUNC PRO TUNC (hereinafter "Assignment") is made this _____ day of May, 2012, to be effective as of September 1, 2001, nunc pro tunc, by THE FEDERAL EMPLOYEES LEGAL DEFENSE FUND, INC., a corporation organized under the laws of Washington, D.C. (hereinafter "Assignor").

This Assignment is made to TWYLAH JAGIELO, an individual of 901 North Nelson Street, Apt. 1014, Arlington, VA 22201 (hereinafter "Assignee").

This Assignment is made with reference to the following facts.

A. As of certain times previous to September 1, 2001, Assignor was the owner of the trademark or service mark "THE FEDERAL EMPLOYEES LEGAL DEFENSE FUND, INC. (& design)" (hereinafter "Trademark") as shown in the below trademark or service mark registration (hereinafter "Registration"):

U.S. Trademark or Service Mark Registration No. 4,057,061
which registered November 15, 2011
in the name of THE FEDERAL EMPLOYEES LEGAL DEFENSE FUND, INC.
on the Principal Register of the Patent and Trademark Office
for "THE FEDERAL EMPLOYEES LEGAL DEFENSE FUND, INC. (& design)"
for certain listed association services in Int'l Class 35.

B. On or about August 7, 2001 Assignee took steps to form the Assignor entity, resulting in the Department of Consumer and Regulatory Affairs (hereinafter "DCRA"), of the Government of Washington, D.C., issuing a certificate of incorporation for the said Assignor entity on or about that same day, apparently under the name "THE FEDERAL EMPLOYEES LEGAL DEFENSE FUND" and apparently having the DCRA File No. 212601.

C. It appears that at a point in time after September 1, 2001, certain persons other than Assignee took action to dissolve the said Assignor entity (contrary to Assignee's intentions) and to form another entity having the same name.

D. At all pertinent times, it was Assignee's intention to have the Trademark and the Registration owned by the Assignor entity and/or by herself as Assignee.

E. Such Trademark and Registration has been used in commerce which may be regulated by Congress in connection with the offering and rendering of the services listed on the Registration and is a valuable asset that symbolizes and embodies goodwill and consumer recognition in the marketplace.

F. To the extent not already accomplished, Assignor intends by this present document to convey to Assignee the entirety of Assignor's right, title and interest (past, present, and future) (U.S. and foreign) in and to the Trademark and all accompanying goodwill and consumer recognition, as well as the said Registration, all to be effective as of September 1, 2001, to the fullest extent permitted by law.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby expressly acknowledged, Assignor does hereby and herewith assign, transfer, sell and convey to Assignee, effective as of September 1, 2001, nunc pro tunc, all of Assignor's right, title, and interest in and to the Trademark, together with all goodwill and consumer recognition symbolized thereby and embodied therein, together with the Registration. To the fullest extent of Assignor's right and title, the above assignment, transfer, and conveyance includes any and all causes of action for infringement of the Trademark and/or Registration, past, present, and future, with the right to sue for and collect and keep for Assignee's own sole use and benefit, any and all proceeds from such causes of action accrued and unpaid or hereafter accruing.

Assignor covenants and agrees that it will at any time on request execute and deliver to Assignee any and all documents and papers as may be necessary or desirable to perfect in Assignee the interests herein conveyed, and further covenants and agrees that it will communicate and cooperate with Assignee to the extent necessary for Assignee to have and enjoy to the fullest extent the interests herein conveyed.

IN WITNESS WHEREOF Assignor executes this TRADEMARK ASSIGNMENT NUNC PRO TUNC on the date first above written, to be effective as of September 1, 2001, nunc pro tunc.

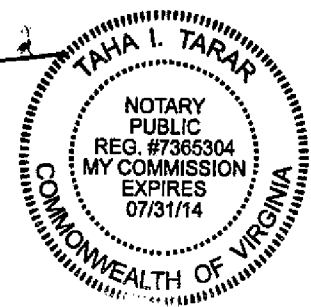
