RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (this "Release"), dated as of June 5, 2012, is made by Madison Capital Funding LLC, as agent for the Lenders (as defined in the Trademark Security Agreement defined below) (the "Agent").

WHEREAS, the Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office;



The Agent agrees, at the Grantor's expense, to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Agent's security interest in the released collateral described herein.
