

TRADEMARK RELEASE

This release of security interest in United States trademarks (this "Release"), effective as of May 24, 2012, is granted by Deutsche Bank Trust Company Americas, with principal offices at 60 Wall Street, New York, New York 10005 ("Grantee"), in its capacity as Collateral Agent for and on behalf of the Secured Creditors (the "Collateral Agent"), to TPI Acquisition Subsidiary, Inc., a Delaware corporation with principal offices at 201 Industrial Parkway, Somerville, NJ 08876 ("Grantor"), as follows:

W I T N E S S E T H:

WHEREAS, pursuant to the terms of the Security Agreement, dated as of November 19, 2010 by and among the Collateral Agent and the other parties thereto (as amended, modified, restated and/or supplemented from time to time, the "Security Agreement") and the Grant of Security Interest in United States Trademarks, dated November 19, 2010, by and between Grantor and the Collateral Agent (with the Security Agreement, the "Security Documents"), Grantor has heretofore granted to the Collateral Agent a security interest in (i) all of the Grantor's right, title and interest in, to and under the United States trademark, trademark registrations, trademark applications and domain names (the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated; and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same (collectively, the "Trademark Collateral"), which security interest was recorded on November 23, 2010 at Reel 4420, Frame 0835 in the United States Patent and Trademark Office; and

WHEREAS, the Collateral Agent wishes to release and restore all right, title and interest in and to the Trademark Collateral to Grantor and to dissolve any and all liens and encumbrances respecting the Trademark Collateral under the Security Documents.

NOW, THEREFORE, for good and valuable consideration, the Collateral Agent hereby releases, discharges, quit claims and relinquishes unto Grantor its security interest in and lien on any and all right, title and interest in the Trademark Collateral. All capitalized terms used but not defined in this Release shall have the meanings ascribed to them in the Security Agreement.
