# SHORT FORM FIRST LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS SHORT FORM FIRST LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of June 7, 2012, by each of the entities listed on the signature pages hereof (or by such entities that becomes a party hereto pursuant to Section 7.14 of the First Lien Pledge and Security Agreement referred to below, each a "Grantor" and, collectively, the "Grantors"), in favor of General Electric Capital Corporation ("GE Capital"), as agent for the Secured Parties (as defined in the First Lien Pledge and Security Agreement referred to below) (in such capacity, the "First Lien Agent").

## **RECITALS:**

- A. Pursuant to the First Lien Credit Agreement dated as of June 7, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among SMG Holdings, Inc., a Delaware corporation ("Parent"), SMG Holdings I, LLC, a Delaware limited liability company ("Holdings I"), SMG Holdings II, LLC, a Delaware limited liability company ("Holdings II"), SMG, a Pennsylvania general partnership (the "Borrower"), the Lenders party thereto, the Swingline Lender, the Issuing Lenders, Credit Suisse Securities (USA) LLC, as a joint lead arranger, GE Capital Markets, Inc., as a joint lead arranger and GE Capital as administrative agent and collateral agent for the Lenders, the Lenders have agreed, subject to the terms and conditions set forth in the Credit Agreement, to extend credit to the Borrower; and
- B. Each Grantor is party to that certain First Lien Pledge and Security Agreement dated as of June 7, 2012 (the "<u>First Lien Pledge and Security Agreement</u>") in favor of the First Lien Agent pursuant to which the Grantors are required to execute and deliver this Short Form First Lien Intellectual Property Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the First Lien Agent to enter into the Credit Agreement and to induce the Lenders to make Loans thereunder, each Grantor hereby agrees with the First Lien Agent as follows:

## **SECTION 1. DEFINED TERMS**

1.1 Unless otherwise defined herein, terms defined in the Credit Agreement or in the First Lien Pledge and Security Agreement shall have the meaning given to them in the Credit Agreement or the First Lien Pledge and Security Agreement, as the case may be.

### SECTION 2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL

2.1 Each Grantor, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations of such Grantor, hereby mortgages, pledges and hypothecates to the First Lien Agent, for the benefit of the Secured Parties, and grants to the First Lien Agent, for the benefit of the Secured Parties, a lien on and security interest in, all of its right, title and interest [SMG Short Form First Lien Intellectual Property Security Agreement]

in, to and under the following Collateral (other than Excluded Assets) of such Grantor (the "Trademark Collateral"):

- (a) all of its Copyrights and Copyright Licenses to which it is a party, including, without limitation, those referred to on Schedule I hereto;
  - (b) all reissues, renewals, continuations or extensions of the foregoing;
- (c) all Proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present, future infringement or dilution of any Copyright or Copyright licensed under any Copyright License.

and

- (d) all of its Patents and Patent Licenses to which it is a party, including, without limitation, those referred to on Schedule I hereto;
- (e) all reissues, re-examinations, continuations, continuations-in-party, divisions or extensions of the foregoing;
- (f) all Proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present, future infringement or dilution of any Patent or Patent licensed under any Patent License.

and

all of its Trademarks and Trademark Licenses to which it is a party, including, without limitation, those referred to on Schedule I hereto:

- (g) all reissues, renewals, continuations or extensions of the foregoing;
- (h) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and
- (i) all Proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present, future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.

# SECTION 3. FIRST LIEN PLEDGE AND SECURITY AGREEMENT

3.1 The security interest granted pursuant to this Short Form First Lien Intellectual Property Security Agreement is granted in conjunction with the security interest granted to the First Lien Agent pursuant to the First Lien Pledge and Security Agreement and each Grantor hereby acknowledges and affirms that the rights and remedies of the First Lien Agent with respect to the security interest in the Trademark Collateral made and granted hereby

are more fully set forth in the First Lien Pledge and Security Agreement, the terms, provisions and conditions of which are incorporated by reference herein as if fully set forth herein.
