1. That the Amended and Restated Certificate of Incorporation of the Corporation is hereby amended by changing Article First thereof so that, as amended, said Article First shall read in its entirety as follows:

"FIRST: The name of the corporation is Vantage Specialty Chemicals, Inc. (the "Corporation")."
