RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of May 18, 2012 ("Effective Date") by **Ableco Finance LLC**, a Delaware limited liability company ("Collateral Agent"), in favor of the Grantors listed on the signature page hereof (collectively, jointly and severally, "Grantors" and each individually "Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Amendment Number One to Trademark Security Agreement by and between Grantors and Collateral Agent dated March 31, 2008 (the "Trademark Security Agreement"), each Grantor granted to Collateral Agent a continuing first priority security interest in and to all of such Grantor's right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the trademark applications and registrations set forth on Schedule 1 attached hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 21, 2008, at Reel/Frame 3763/0722; and

WHEREAS, Grantors have requested and Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest and continuing lien on the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby, without any representation or warranty, and without recourse to Collateral Agent, (a) terminates the Trademark Security Agreement, and (b) terminates, cancels and releases any and all security interests it has against the Trademark Collateral.

For the avoidance of doubt, nothing in this Release of Security Interest in Trademarks shall be deemed a representation or warranty with respect to the Trademark Collateral, any Grantor's or the Collateral Agent's right, title or interest therein or thereto, or the release granted herein, and neither the Grantors nor any other third party shall have any recourse against the Collateral Agent or any lender, in any way in connection with the Trademark Collateral or this Release of Security Interest in Trademarks.
