Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned corporation adopts these Articles of Amendment to its Amended and Restated Articles of Incorporation:

1. The name of the corporation is CRIBIS CORPORATION (the "Corporation"), document number P99000030595.

2. The following Amendment to the Amended and Restated Articles of Incorporation was adopted by the sole Director of the Corporation and the sole Shareholder of the Corporation, the number of votes cast being sufficient for approval, on the 21<sup>st</sup> day of December, 2010.

ARTICLE I, in its entirety, of the Amended and Restated Articles of Incorporation of the Corporation be and hereby is amended and restated in its entirety as follows:

NAME

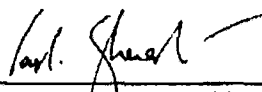
The name of the Corporation shall be "CRIF CORPORATION".
