RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of June 5, 2012 ("Effective Date") by and between **RBS CITIZENS, N.A.**, ("Grantee"), and **FAB-TECH, INC.**, a Vermont corporation ("Grantor").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates, cancels and releases any and all security interests it has against the Trademarks pursuant to the terms of the Security Agreement.


