Assignor further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Marks and the Property, including without limitation PTO Form-1594 Recordation Form Cover Sheet to evidence this Assignment on the records of the United State Patent and Trademark Office .

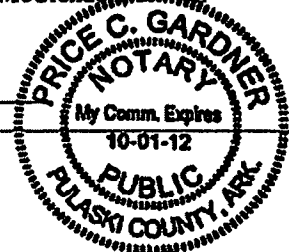
