TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this “**Agreement**”) dated as of June 7, 2012 is executed and delivered by BLACK LETTER DISCOVERY, INC., a California corporation (“**Grantor**”), in favor of WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, pursuant to the Loan Agreement referred to below. Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Loan Agreement.

RECITALS:

WHEREAS, Grantor has adopted, used and is using the trademarks set forth on Annex 1 hereto (collectively, the “**Trademarks**”);

WHEREAS, Grantor has executed and delivered in favor of Lender that certain Loan and Security Agreement dated as of even date herewith among Grantor, Excelerate Discovery, LLC, Document Decisioning, Inc., Callidus Corp., Inc., and Lender (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the “**Loan Agreement**”); and

WHEREAS, pursuant to the Loan Agreement, Grantor has granted to Lender a security interest in, among other things, all right, title and interest of Grantor in and to each of the Trademarks to secure the prompt and complete payment, performance and observance of all Grantor’s Obligations;

NOW, THEREFORE, in consideration of the premises and the agreements, provisions and covenants herein contained, Grantor agrees as follows:.

1. Incorporation of Loan Agreement. The Loan Agreement, and the terms and provisions thereof, are hereby incorporated herein in their entirety by this reference thereto.

2. Grant and Reaffirmation of Grant of Security Interests. To secure the prompt and complete payment, performance and observance of all Grantor’s Obligations, Grantor hereby grants to Lender (and hereby ratifies, confirms and reaffirms its grant pursuant to the Loan Agreement of) a continuing security interest in all of the following property and interests in property of Grantor, whether now owned and existing or hereafter acquired or arising:


(a) all of the Trademarks, all recordings and registrations thereof and applications therefor, all renewals and extensions thereof, all rights corresponding thereto, and all goodwill associated therewith or symbolized thereby; and

(b) all proceeds of the foregoing, including, without limitation, all general intangibles embodying, incorporating, evidencing or otherwise relating or pertaining to the Trademarks.
