TRADEMARK LICENSE AGREEMENT

THIS TRADEMARK LICENSE AGREEMENT is effective as of May 1, 2007 by and between RoomStore, Inc., a Virginia corporation ("Licensor"), and Miskelly Furniture Warehouse, Inc., a Mississippi corporation ("Licensee").

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises hereinafter set forth, the parties agree as follows:

1. **GRANT OF LICENSE.** Licensor grants to Licensee an exclusive, transferable (upon the conditions set forth below in paragraph 27) license within the licensed territory to use the Marks in its name and in connection with the goods and services covered by the registrations referred to in Schedule A and Licensee accepts the license subject to the following terms and conditions.
2. **TERRITORY.** Licensee shall have the exclusive right to use the Marks under this license in the following trading areas: Jackson Market (Hinds, Madison, Rankin & Warren Counties), Meridian and Hattiesburg, Mississippi (the "Territory"), and shall have a non-exclusive license to use the Marks on its company-sponsored web site.

9. **TERM.** This Agreement shall continue in force and effect for ten(10)years, beginning on the date first set forth above, unless sooner terminated as provided for herein. Additionally, Licensee shall have the option to extend the term of this Agreement for up to three additional, five year terms. Each such option shall be deemed to have been exercised unless Licensee provides written notice of its intention not to exercise such option at least thirty(30) days prior to expiration of the then-current term.
