**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the "Agreement") is made as of the 17 day of April, 2012, between VCG, LLC, a Georgia corporation and formerly known as VCG, Inc. (collectively, "VCG, Inc.") and JCP CO-INVESTMENT IV, L. P. ("JCP Co-Investment"), a Virginia limited partnership.
