RELEASE OF TRADEMARK SECURITY INTEREST, dated as of June 13, 2012 (this "Release"), by JPMORGAN CHASE BANK, N.A. (as successor in interest to the Chase Manhattan Bank) as Collateral Agent (as defined below), in favor of Springs Global US, Inc. (as assignee of the Trademarks from the Borrower (as defined below)). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Security Agreement, as applicable, referred to below.

Reference is made to (i) the Credit Agreement dated as of September 5, 2001, as amended and restated as of December 7, 2004 (the "Credit Agreement"), among Springs Industries, Inc. (the "Borrower"), the lenders from time to time party thereto, Wachovia Bank, National Association, as syndication agent, and JPMorgan Chase Bank, N.A., as administrative agent (in such capacity, the "Administrative Agent") and (ii) the Security Agreement dated as of September 5, 2001 (the "Security Agreement"), among the Borrower, the subsidiaries of the Borrower party thereto (together with the Borrower, the "Grantors") and the Chase Manhattan Bank, as collateral agent (in such capacity, the "Collateral Agent").

WHEREAS, pursuant to the Security Agreement, the Grantors granted a security interest to the Collateral Agent, for the benefit of the Secured Parties, in, among other things, the trademarks of the Grantors set forth on Schedule I hereto (the "Trademarks"), which security interest was recorded with the United States Patent & Trademark Office on September 24, 2001, at Reel/Frame 2368/0001; and

WHEREAS, pursuant the Termination and Release Agreement dated as of December 30, 2005, among the Borrower, the subsidiaries of the Borrower party thereto, the Administrative Agent and the Collateral Agent, the Collateral Agent agreed to release the security interests held by it for the benefit of the Secured Parties in, among other things, the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby release, terminate, cancel, relinquish and discharge any and all security interests it has, if any, in the Trademarks.

This Release is made without representation or warranty by, or recourse to, the Collateral Agent or any other Secured Party. THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.
