FIRST: Ahlstrom Filtration, Inc. (the "Corporation") filed its Certificate of Incorporation, under the name Knowlton Brothers, in New York State on February 26, 1892. Ahlstrom Engine Filtration LLC is a limited liability company organized in Delaware on December 1, 1999. An application for authority has not been filed by Ahlstrom Engine Filtration LLC in New York.

SECOND: An Agreement of Merger with Ahlstrom Engine Filtration LLC has been approved and executed by the Corporation, effective December 1, 1999.

THIRD: The name of the surviving foreign limited liability company is:

Ahlstrom Engine Filtration LLC

FOURTH: The merger shall be effective upon the filing by the Department of State of the certificate.

FIFTH: The surviving foreign limited liability company hereby agrees that it may be served with process in this state in any action or special proceeding for the enforcement of any liability or obligation of any domestic company previously amenable to suit in this state that is to merge and for the enforcement that is provided in the Limited Liability Company Law of the right of members of any domestic company to receive payment for their interest against the surviving foreign limited liability company.

SIXTH: The Secretary of State is designated as agent of the foreign limited liability company upon whom process against it may be served. The post office address to which the Secretary of State shall mail a copy of any process against the corporation served

upon him is c/o Cameron, Hornbostel & Holbrook LLP, 230 Park Avenue, New York, NY 10169.

**SEVENTH:** The surviving foreign limited liability company agrees, subject to the provisions of section six hundred twenty-three of the business corporation law and section one thousand five of this article, that the surviving foreign limited liability company will promptly pay to the shareholders of each constituent domestic business corporation and the members of each domestic limited liability company the amount, if any, to which they shall be entitled under the provisions of the business corporation law and this chapter relating to the right of shareholders and members to receive payment for their interest.

**EIGHTH:** The agreement of merger is on file at the place of business of the surviving foreign limited liability company. The address of such foreign limited liability company is Ahlstrom Engine Filtration LLC, Eastgate Town Center, 5600 Brainerd Road, Suite 100, Chattanooga, TN 37411.


