**TRADEMARK SECURITY AGREEMENT**

Pursuant to a Security Agreement made as of June 14, 2012 (the "Security Agreement"), by **Milestones Products Company, LLC**, an Indiana limited liability company (together with its successors and assigns, the "Grantor"), and other grantors named therein, with **Texas Capital Bank, National Association**, a national banking association (the "Bank"), Grantor hereby collaterally assigns and pledges, and grants to the Bank, a security interest in and lien on, and confirms and ratifies the assignment, pledge, grant, and lien on, all of Grantor's right, title and interest in and to the trademarks, trade names, corporate names, business names, fictitious business names, trade styles, trade dress, service marks, logos, source or business identifiers, prints, labels, designs, now existing or hereafter acquired, including all registrations, applications, and renewals thereof, together with that part of the good will of the business symbolized thereby (any and all being the "Trademarks") for the Trademarks referred to in Schedule I attached hereto, including products, advertising, and packaging embodying the Trademarks, and all proceeds from the sale, use, or lease of the Trademarks and products, to secure performance of the terms of the Security Agreement.

Bank's security interest in the Trademarks can be terminated only in accordance with the terms of the Security Agreement.
