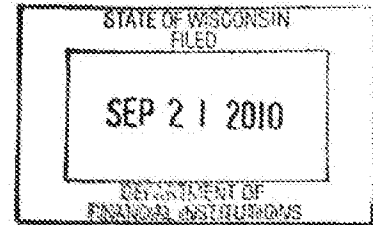

The undersigned, Agropur inc., a Wisconsin corporation ("Agropur"), pursuant to Section 302A.521 of the Minnesota Business Corporations Act (the "MN Act") and Section 180.1105 of the Wisconsin business corporation law (the "WI Act"), hereby executes the following Articles of Merger:

1. Plan of Merger. The plan of merger by and between Schroeder Milk Co., Inc., a Minnesota corporation ("Schroeder") with and into Agropur (the "Plan of Merger") dated as of September 13, has been approved and adopted by the Boards of Directors of Agropur and Schroeder and is as attached hereto as Exhibit A. The Plan of Merger was authorized, approved and adopted by each corporation that is a party to the merger as required under Chapter 302A of the MN Act and sec. 180.1104 of the WI Act. The surviving corporation is a Wisconsin Domestic Corporation that is the parent and the merger was approved in accordance with sec. 180.11045 and the requirements of sec. 180.11045(2) of the WI Act have been satisfied. The Plan of Merger was drafted outside of the State of Wisconsin.

2. Names. The names of the constituent entities proposing to merge, and their respective states of organization are as follows:

3. Surviving Entity. Agropur will be the surviving corporation.

4. Effective Time: The effective time of the merger shall be 12:01 a.m. on October 1, 2010.

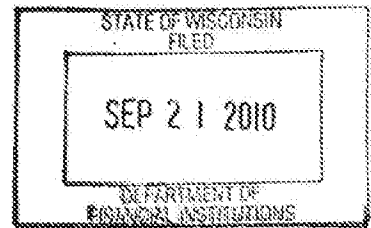

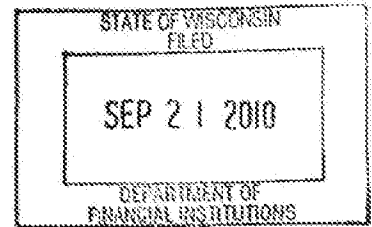
