PATENT AND TRADEMARK SECURITY AGREEMENT

Pursuant to a Security Agreement made as of June 14, 2012 (the Security Agreement"), by **Computerized Imaging Reference Systems, Inc.**, a Virginia corporation (together with its successors and assigns, the "Grantor"), and other grantors named therein, with **Castleray, LLC**, a Delaware limited liability company (the "Lender"), Grantor hereby collaterally assigns and pledges, and grants to the Lender, a security interest in and lien on, and confirms and ratifies the assignment, pledge, grant, and lien on, all of Grantor's right, title and interest in and to the following:

(a) patents, and all applications, reissues, reexaminations, continuations, divisions, continuations-in-part, extensions and renewals thereof, and the inventions disclosed therein, and all improvements, know-how, and developments now or hereafter made (any and all being the "Patents") for the Patents referred to in Schedule I attached hereto including products embodying the Patents, and all proceeds from the sale, use or lease of the Patents and products, and


(b) trademarks, trade names, corporate names, business names, fictitious business names, trade styles, trade dress, service marks, logos, source or business identifiers, prints, labels, designs, now existing or hereafter acquired, including all registrations, applications, and renewals thereof, together with that part of the good will of the business symbolized thereby (any and all being the "Trademarks") for the Trademarks referred to in Schedule II attached hereto, including products, advertising, and packaging embodying the Trademarks, and all proceeds from the sale, use, or lease of the Trademarks and products, to secure performance of the terms of the Security Agreement.

Lender's security interest in the Patents and Trademarks is subject and inferior to a security interest therein in favor of **Texas Capital Bank, National Association**, and can be terminated only in accordance with the terms of the Security Agreement.


