TRADEMARK QUITCLAIM AND ASSIGNMENT

THIS TRADEMARK QUITCLAIM AND ASSIGNMENT (the "**Quitclaim**") is made by NutraMarks, Inc., a Delaware corporation with its principal place of business at 1500 Kearns Boulevard, Suite B200, Park City, Utah, 84060 ("**NutraMarks**"), in favor of Aesthetic Devices, Inc., a California corporation with its principal place of business at 621 Professional Center, Novato, California, 94947 ("**Aesthetic Devices**").

WHEREAS, since December 15, 2000, Aesthetic Devices has been the owner of all rights, title, and interests (collectively, the "**Interests**") in and to the mark DERMAGLOW (the "**Mark**") for medicated skin lotion in the United States and the United States registration therefor (the "**Registration**"), i.e. registration number 1257388 on the Principal Register maintained by the United States Patent and Trademark Office (the "**USPTO**"), along with (i) the goodwill associated with and symbolized by the Mark (collectively, the "**Goodwill**") and (ii) all causes of action, claims, and demands arising from any infringement or misappropriation, including past infringements and misappropriations, of the Mark (collectively, the "**Claims**," and together with the Mark and the Goodwill, the "**Rights**");

WHEREAS, on or around November 30, 2010, NutraMarks filed a trademark assignment with the USPTO (the "**NutraMarks Assignment**") wherein NutraMarks asserted it was the assignee of all Interests in and to the Rights;

WHEREAS, NutraMarks in good faith believed it had obtained the Interests in and to the Rights via the NutraMarks Assignment from The Heritage Store, Inc., a Virginia corporation ("**HSI**"), but has now learned HSI did not own title to the Mark after December 15, 2000 and thereafter lacked any right to transfer or assign any Interests it may have had in the Rights;

WHEREAS, NutraMarks acknowledges: (i) the NutraMarks Assignment was void and effected no assignment to NutraMarks of any Interests in or to any of the Rights; and (ii) NutraMarks has never owned any Interests in or to the Rights; and

WHEREAS, NutraMarks now wishes to memorialize in writing its understanding that, since December 15, 2000, Aesthetic Devices, and not NutraMarks or HSI, has been and remains the owner of the Interests in and to the Rights.

NOW, THEREFORE, to facilitate the correction of the USPTO's records such that the same reflect Aesthetic Devices as the owner of all Interests in and to the Rights, NutraMarks hereby quitclaims and assigns to Aesthetic Devices, *nunc pro tunc* as of November 30, 2010 immediately following the NutraMarks Assignment, any and all Interests, if any, held by NutraMarks in and to the Rights.

IN WITNESS WHEREOF, NutraMarks has caused this Quitclaim to be duly executed by its authorized officer as of the date written below.
