Assignor does hereby sell, transfer, convey, assign and deliver to Assignee all right, title and interest of Assignor in and to the Assigned Trademarks, the registrations and applications for registrations thereof, and the goodwill of the business connected with the use thereof and symbolized thereby, free and clear of all liens; all rights of priority therein in any country as may now or hereafter be granted to it by law, treaty or other international convention; and all rights, interests, claims and demands recoverable in law or equity, that Assignor has or may have in profits and damages for past, present and future infringements of the Assigned Trademarks, including, without limitation, the right to compromise, sue for and collect such profits and damages; the same to be held and enjoyed by Assignee, its successors and assigns or their legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

Assignor hereby agrees that Assignor shall, and shall cause its affiliates to, at its own expense, execute and deliver, or cause to be executed and delivered, such additional instruments, documents, conveyances or assurances and take such other actions as may be necessary, or otherwise reasonably requested by Assignee, to render effective the consummation of the transactions contemplated by this Assignment and the Agreement or otherwise carry out the intent and purposes of this Assignment and the Agreement.

All representations and warranties from Assignor to Assignee in the Agreement with respect to the Assigned Trademarks and the other rights assigned above

are incorporated herein by reference.

This Assignment shall be governed by, and construed in accordance with, the laws of the United States, in respect to trademark, copyright, and patent issues and in all other respects including as to validity, interpretation and effect by the laws of the Commonwealth of Virginia, without giving effect to the conflict of laws rules thereof.
