**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of June 15, 2012, is made by **GENERAL ELECTRIC CAPITAL CORPORATION**, as Agent (the "**Agent**"), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, in connection with that certain Credit Agreement dated as of December 28, 2010 (as amended, restated, supplemented or otherwise modified from time to time, and together with all general security agreements, trademark security agreements and patent security agreements entered into in connection therewith or in connection with prior versions thereof, the "**Credit Agreement**"), among OraPharma Holdings, Inc., a Delaware corporation ("**Company**"), the other Credit Parties, the Lenders and the Agent, the Lenders made loans and other financial accommodations to the Company;

WHEREAS, in connection with the Credit Agreement, and pursuant to those certain agreements described on Annex I attached hereto (the "**Trademark Security Agreement**," and the "**Patent Security Agreement**," collectively, the "**Security Agreements**"), OraPharma, Inc., a Delaware corporation ("**OraPharma**") granted to Agent for the benefit of the Secured Parties a Lien on and security interest in all of its right, title and interest in, to and under (A)(i) all of its Trademarks, including those referred to on Schedule 1 to that certain Trademark Security Agreement; (ii) all renewals and extensions of the foregoing; (iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and (iv) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof (collectively, the "**Trademark Collateral**")¹; and (B)(i) all of its Patents, including those referred to on Schedule 1 to that certain Patent Security Agreement; (ii) all reissues, reexaminations, continuations, continuations-in-part, divisionals, and extensions of the foregoing; and (iii) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, violation or other impairment thereof (collectively, the "**Patent Collateral**") (together, the "**Intellectual Property Collateral**," including those listed on Annex I attached hereto); and

WHEREAS, the Security Agreements were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Annex I hereto.

NOW THEREFORE, the Agent hereby **RELEASES**, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Intellectual Property Collateral to OraPharma.

The Agent agrees, at OraPharma's expense, to cooperate with OraPharma and to provide OraPharma with the information and additional authorization reasonably required or desirable to effect the release of the Agent's security interest in the released collateral described herein.



