TO THE

DWC-Aphex, LLC, a limited liability company duly organized and existing under the laws of the state of Utah, does hereby amend its Articles of Organization in accordance with Section 48-2c-408 of the Utah Revised Limited Liability Company Act (the "Utah LLC Act"), as follows:

FIRST: The name of the company is DWC-Aphex, LLC (the "Company").

SECOND: The Articles of Organization are hereby amended to change the name of the Company by deleting Article 1 in its entirety and inserting the following in lieu thereof:

"1. Name. The name of the limited liability company is **Aphex LLC** (the "Company")."
