NOTICE OF RELEASE, RELINQUISHMENT & DISCHARGE OF SECURITY INTEREST

WHEREAS Comerica Bank (the "Creditor") whose full post office address is Suite 2210, South Tower, Royal Bank Plaza, P.O. Box 61, Toronto, Ontario, Canada M5J 2J2 and QuickPlay Media Inc. (the "Debtor") whose address is 190 Liberty Street, 2nd Floor, Toronto, Ontario, Canada, M6K 3L5 entered into a General Security Agreement dated March 29, 2007 (the "Security Agreement"), by which the Debtor granted to the Creditor a security interest in the trade-mark registrations and applications and patent applications on the attached Schedule "A" ("The Intellectual Property");

AND WHEREAS the Security Agreement was subsequently registered at the Canadian Intellectual Property Office and The United States Patent and Trademark Office; and

AND WHEREAS the Creditor has agreed to release the Debtor from its obligations under the Security Agreement and to discharge the security granted by the Debtor for such obligations with respect to the Intellectual Property;

NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each of the parties hereto, the parties agree as follows:

1. The Creditor hereby relinquishes, releases and terminates all of its rights, title and interests in and to the Intellectual Property.
2. The Creditor hereby directs the Canadian Registrar of Trade-marks, Canadian Commissioner of Patents, United States Commissioner of Trademarks and United States Commissioner of Patents to record the present Notice of Release, Relinquishment & Discharge of Security Interest (the "Notice") in such places as they deem necessary or advisable to give effect hereto.
3. The present Notice may be executed in separate counterparts by the parties hereto, each of which when executed and delivered shall be an original, but all of which shall constitute but one and the same instrument.
4. The present Notice is executed in accordance with and is subject to, governed by and interpreted in accordance with the laws of the province of Ontario and the laws of Canada applicable therein.




