**MEMORANDUM OF GRANT OF SECURITY INTEREST  
(TRADEMARKS)**

THIS MEMORANDUM OF GRANT OF SECURITY INTEREST, dated as of this 6<sup>th</sup> day of November, 2009 is executed by SKYWORKS INTERACTIVE, INC., a New Jersey corporation (“**Interactive**”), SKYWORKS VENTURES, INC. a Delaware corporation (“**Ventures**”), in favor of SHARON A. FORDHAM (the “**Lender**”). Interactive is a wholly owned subsidiary of Ventures. Interactive and Ventures (collectively, “**Grantor**”) are indebted to the Lender by virtue of the consummation of the transactions contemplated by that certain Revolving Loan And Security Agreement of even date herewith (the “**Loan Agreement**”), by and between Grantor and Lender.

A. Grantor has adopted, used and is using the trademarks, more particularly described on *Schedules 1-A* and *1-B* annexed hereto and made a part hereof, which trademarks are registered or subject to an application for registration in the United States Patent and Trademark Office (collectively, the “**Trademarks**”).

B. Grantor and other entities party thereto from time to time have entered into a Security Agreement (Intellectual Property) dated as of November 6, 2009 (as amended, restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) in favor of Lender.

C. Pursuant to the Security Agreement, Grantor has granted to Lender a security interest in all right, title and interest of Grantor in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the customer lists and records related to the Trademarks and the applications and registrations thereof (the “**Collateral**”), to secure the payment, performance and observance of the Secured Obligations, as defined in the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Grantor does hereby further grant to Lender a security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

Grantor does hereby further acknowledge and affirm that the rights and remedies of Lender with respect to the security interest in the Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


