RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE is made as of June 15, 2012 by MCG Capital Corporation in its capacity as administrative agent (“*Secured Party*”) under that certain Junior Security Agreement (the “*Security Agreement*”) dated as of January 5, 2007 by and among the grantors party thereto and the Secured Party.

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, Coastal Sunbelt Produce Company, a Maryland corporation (the “*Grantor*”), granted a continuing security interest in and continuing lien upon the trademarks and trademark applications shown on Schedule I hereto (the “*Trademark Collateral*”) to the Secured Party for the benefit of the holders of the secured obligations identified therein; and

WHEREAS, pursuant to a Notice of Grant of Security Interest in Trademarks, the Secured Party recorded a security interest in said Trademark Collateral with the Assignment Division of the United States Patent and Trademark Office on January 16, 2007 at Reel 003461, Frame 0068; and

WHEREAS, the Secured Party has agreed to release its rights under said Security Agreement and to re-convey to Grantor any and all rights in and to the Trademark Collateral.

NOW THEREFORE, in consideration for the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby terminates, releases and discharges its security interest in and to all of Grantor’s right, title and interest in and to the Trademark Collateral originally granted to Secured Party pursuant to the Security Agreement.
2. Secured Party, to the extent granted in the Security Agreement, hereby assigns, grants and otherwise re-conveys to Grantor, without any representation, recourse or undertaking by Secured Party, any and all of its right, title and interest in and to the Trademark Collateral and all goodwill associated therewith originally granted to Secured Party pursuant to the Security Agreement.
3. Upon the request of Grantor, Secured Party further agrees to execute all documents necessary to demonstrate and confirm the parties’ intent under this Release of Trademark Security Interest.

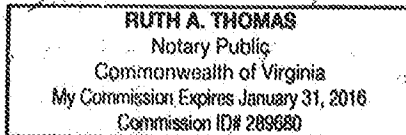
