TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT, dated as of the 11th day of June, 2012, is made by and among DYNO SEASONAL SOLUTIONS, LLC, a Delaware limited liability company (the “Grantor”), and SUNTRUST BANK, as administrative agent for the Lenders (defined below) (in such capacity, the “Secured Party”). Capitalized terms used but not defined herein shall have the meanings assigned to such terms in the Credit Agreement, dated as of the date hereof, among Dyno LLC, Dyno Decorative Bows LLC, the Grantor, the Guarantors party thereto, the financial institutions party thereto as “Lenders”, and the Secured Party (as amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”).


WHEREAS, the Grantor has, pursuant to the Security Agreement, granted to the Secured Party a security interest in and to all of the right, title and interest of the Grantor in, to and under the Collateral, including, without limitation, the Grantor’s Trademarks and associated goodwill (as defined in the Security Agreement), as collateral security for the payment and performance in full when due of the Obligations; and

WHEREAS, the Grantor and the Secured Party wish to further memorialize the security interest described above as it relates to the registered trademarks and pending federal trademark applications identified in Schedule A, attached hereto, and incorporated herein by this reference (the “Specified Trademarks”).

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Grantor hereby grants unto the Secured Party a security interest in and lien on all of their right, title and interest in the Specified Trademarks, as collateral security for the payment and performance in full when due of the Obligations. Grantor hereby acknowledges and affirms that the rights and remedies of the Secured Party with respect to the security interest in the Specified Trademarks made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
