**TRADEMARK ASSIGNMENT**

This Trademark Assignment Agreement is made and entered into as of April 10, 2012 (the "Effective Date"), by and between Kandu Enterprises, LLC, a Colorado limited liability company ("Assignor"), and MyChelle Natural Skin Care, LLC, a Colorado limited liability company ("MyChelle").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Assignor hereby conveys, transfers, assigns, and delivers to MyChelle all of Assignor's rights, title, and interest in, to, and under the Mark, including all common law rights connected therein; together with the goodwill of the business symbolized thereby and associated therewith, and any registrations of and application to register the Mark, including the Registration; and together with all claims for damages by reason of past, present, or future infringement or other unauthorized use of the Mark, and with the right to sue for and collect damages.

Assignor further covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing, completing, or vesting in MyChelle full rights, title, and interest in and to the Mark.
