**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS terminates and releases the TRADEMARK SECURITY AGREEMENT dated as of August 2, 2011 by and between **JPMORGAN CHASE BANK, N.A.**, as administrative agent ("Administrative Agent") and **DAIRYLAND USA CORPORATION** ("Dairyland"), a New York corporation, and by and between Administrative Agent and **BEL CANTO FOODS, LLC** ("Bel Canto"), a New York limited liability company, and dated November 7, 2011 by and between Administrative Agent and **THE CHEFS' WAREHOUSE WEST COAST, LLC** ("CWWC"), a Delaware limited liability company, and dated December 23, 2011 by and between Administrative Agent and **THE CHEFS' WAREHOUSE, INC.** ("CWI"), a Delaware corporation (Dairyland, Bel Canto, CWWC and CWI each, an "Assignor", and collectively, the "Assignors", and each with an office located at 100 East Ridge Road Ridgefield, CT 06877).

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby terminates, releases and discharges the security interests granted to it by Assignors in (i) all of the Assignors' right, title and interest in and to those United States trademarks, trademark registrations and trademark applications set forth on Schedule A attached hereto, along with the goodwill appurtenant thereto (collectively, the "Marks"), (ii) all of the reissues, extensions or continuations of the Marks, (iii) the goodwill associated with such Marks, (iv) all causes of action arising prior to the date hereof for infringement of any of the Marks or unfair competition regarding the same and (v) all proceeds of any of the foregoing.

Administrative Agent hereby re-assigns to each Assignor any right, title and interest it may have in, to and under the Marks and authorizes and requests the United States Patent and Trademark Office, and any other location where the security interest was filed, to note and record the existence of such release hereby given.

The aforementioned security interests were previously respectively recorded in the U.S. Patent and Trademark Office (i) on August 3, 2011, at **Reel 004596, Frame 0829**, (ii) on August 3, 2011, at **Reel 004596, Frame 0807**, (iii) on November 9, 2011, at **Reel 004657, Frame 0876**, (iv) on December 25, 2011, at **Reel 004686, Frame 0914** and (v) on January 3, 2012, at **Reel 004689, Frame 0975**.

This RELEASE OF SECURITY INTEREST IN TRADEMARKS is made effective as of April 25, 2012.
