TERMINATION OF AMENDMENT AND CONFIRMATION OF SHORT-FORM IP  
SECURITY AGREEMENT

THIS TERMINATION OF AMENDMENT AND CONFIRMATION OF SHORT-FORM IP SECURITY AGREEMENT is made and entered as of August 1, 2011 by GENERAL ELECTRIC CAPITAL CORPORATION, a Delaware Corporation, as Administrative Agent on behalf of the Lenders ("Lender") and BACK BAY RESTAURANT GROUP, INC., a Delaware Corporation ("Borrower"), PHEASANT MALL RESTAURANT GROUP, INC., a New Hampshire Corporation ("Pheasant Mall"), and other Credit Parties., all as defined in the Loan Agreement of July 11, 2006.

RECITALS

WHEREAS, pursuant to said Loan Agreement, the Lender, Borrower, Pheasant Mall and other Credit Parties have entered into to a Short-Form IP Security Agreement (the "Short Form Security Agreement") executed as of July 11, 2006,

WHEREAS, Lender, subsequently agreed to increase the principal amount of the credit facilities executed by the Short Form Agreement and to certain other amendments to the documents evidencing such credit facilities and Borrower, Pheasant Mall and other Credit Parties and Administrative Agent, on behalf of the Secured Parties, wished to confirm and ratify the Short Form IP Security Agreement notwithstanding such amendments, and

WHEREAS, in connection with the above, Lender, Borrower, Pheasant Mall and other Credit Parties executed in favor of the Administrative Agent an Amendment and Confirmation of Short-Form IP Security Agreement dated December 28, 2007 (the "Amendment and Confirmation of Short-Form IP Security Agreement") which renewed and extended to the Administrative Agent a Security Interest and Lien upon all of Borrower's and any Credit Party's Intellectual Property including the trademarks listed on the attached Exhibit A, which Amendment and Confirmation of Short-Form IP Security Agreement has been recorded with the United States Patent and Trademark Office on January 10, 2008 at reel/frames 3693/0780-0788.

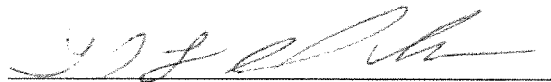
WHEREAS, on August 1, 2011, Borrower paid all amounts outstanding on said Loan and said Loan Agreement has terminated, and

WHEREAS, upon verification of said payment, Administrative Agent has agreed to prepare and record or file the appropriate lien amendments or releases with respect to the property that secures the obligations under the Contract(s).

NOW THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent hereby relinquishes, releases and terminates its Security Interest and Lien in said Intellectual Property including trademarks identified on the attached Exhibit A. Administrative Agent by its duly authorized officer has caused this Termination of Amendment and Confirmation of Short-Form IP Agreement to be executed as an instrument under seal as of the date first written above.
