TERMINATION OF SHORT-FORM IP SECURITY AGREEMENT

THIS TERMINATION OF SHORT-FORM IP SECURITY AGREEMENT is made and entered as of August 1, 2011 by GENERAL ELECTRIC CAPITAL CORPORATION, a Delaware Corporation, as Administrative Agent on behalf of the Lenders ("Administrative Agent") and BACK BAY RESTAURANT GROUP, INC., a Delaware Corporation ("Borrower"), and other Credit Parties, all as defined in the Loan Agreement described below.

RECITALS

WHEREAS, the Administrative Agent, Borrower and other Credit Parties have previously entered into certain Loan, Guaranty and Security Agreements pursuant to, and subject to the terms and conditions of the Loan Agreement dated as July 11, 2006 ("Loan Agreement"),

WHEREAS, in connection with said Loan Agreement, the Borrower and other Credit Parties executed in favor of the Administrative Agent a Short-Form IP Security Agreement dated July 11, 2006 (the "Short-Form IP Security Agreement") which granted to the Administrative Agent a Security Interest and Lien upon all of Borrower's and any Credit Party's Intellectual Property including the trademarks listed on the attached Exhibit A, which Short-Form IP Security Agreement has been recorded with the United States Patent and Trademark Office on July 21, 2006 at reel/frames 3353/0018-0027.

WHEREAS, on August 1, 2011, Borrower paid all amounts outstanding on said Loan and said Loan Agreement has terminated, and

WHEREAS, upon verification of said payment, Administrative Agent has agreed to prepare and record or file the appropriate lien amendments or releases with respect to the property that secures the obligations under the Contract(s).

NOW THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent hereby relinquishes, releases and terminates its Security Interest and Lien in said Intellectual Property, including the trademarks as listed on the attached Exhibit A. Administrative Agent by its duly authorized officer has caused this Termination of Short-Form IP Agreement to be executed as an instrument under seal as of the date first written above.
