TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT, dated as of March 22, 2012 made by DIGITAL RISK, LLC, a Delaware limited liability company with an address at 2301 Maitland Center Parkway, Suite 165, Maitland, FL 32751 ("Grantor"), and FIFTH THIRD BANK, an Ohio banking corporation, with offices at 200 East Robinson St., 8th Floor, Orlando, FL 32801, as lender (in such capacity, "Lender").

Capitalized terms not otherwise defined herein have the meaning set forth in the Patent and Trademark Security Agreement, of even date herewith, between Grantor and the Lender (the "Patent and Trademark Security Agreement").

WITNESSETH:

WHEREAS, the Grantor has acquired an interest in certain trademarks identified in Exhibit I hereto (the "Trademarks");

WHEREAS, the Grantor is the borrower under, and has entered into, a loan and security agreement, dated as of March 22, 2012 (as the same may be modified, amended, extended or restated from time to time, the "Loan Agreement"), with the Lender, pursuant to which the Lender has agreed to make revolving loans to the Grantor;

WHEREAS, it is a condition precedent to Lender's entry into the Loan Agreement that the Grantor shall have executed and deliver the Patent and Trademark Security Agreement to the Lender;

WHEREAS, the Grantor wishes to grant to the Lender a security interest in certain of its property and assets to secure the performance of its obligations under the Loan Agreement and the other Loan Documents;

WHEREAS, the Grantor and the Lender by this instrument seek to confirm and make a record of the grant of a security interest in the Trademarks.
