

FIRST: That, in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware (the "DGCL"), the Board of Directors of the Corporation duly adopted resolutions setting forth a proposed amendment to the Certificate of Incorporation of the Corporation (this "Amendment") and declaring this Amendment advisable.

SECOND: That this Amendment has been consented to and duly approved and adopted by the sole stockholder of all of the issued and outstanding stock of the Corporation entitled to vote thereon in accordance with the provisions of Section 228 and Section 242 of the DGCL and Section 8 of the By-Laws of the Corporation.

THIRD: That Article First of the Certificate of Incorporation of the Corporation is hereby amended and restated in its entirety to read as follows:

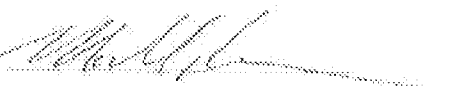
"FIRST: The name of the Corporation is New Aurora Corporation (hereinafter the "Corporation")."
