## RELEASE OF SECURITY INTEREST IN TRADEMARKS

### RECITALS:



NOW THEREFORE, the obligations secured by the Security Interests having been satisfied and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Senior Agent hereby releases, discharges, quitclaims and relinquishes to the Grantors the Security Interests in the Trademark Collateral, granted to Senior Agent by the Grantors pursuant to the Security Agreements and the IP Security Agreements.
