**NOTICE OF GRANT OF SECURITY
INTEREST IN TRADEMARKS**

THIS NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (the "Notice") is made by Dermatologic Cosmetic Laboratories Ltd., a Connecticut corporation, having its chief executive office and principal place of business at 20 Commerce Street, East Haven, Connecticut 06512 (the "Grantor"), in favor of Connecticut Development Authority, a body politic and corporate constituting a public instrumentality and political subdivision of the State of Connecticut, having its principal place of business at 999 West Street, Rocky Hill, Connecticut 06067-3405 (the "Lender"), to evidence the grant by Grantor to Lender of a continuing perfected lien and security interest in the collateral described below pursuant to the terms of a certain Security Agreement dated as of June 25, 2012, by and between Grantor and Lender (the "Security Agreement"), to secure Grantor's "Indebtedness" to Lender under the terms of the Security Agreement.

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Grantor agrees as follows:

To secure the payment and performance of the "Indebtedness" of Grantor to Lender under the Security Agreement, Grantor hereby grants to Lender a continuing perfected lien and security interest in the following:


All of Grantor's right, title and interest in and to all of the following: (i) all state (including common law), federal and foreign trademarks, service marks and trade names, and applications for registration of such trademarks, service marks and trade names, all licenses relating to any of the foregoing and all income and royalties with respect to any business (including such marks, names and applications described on Schedule A attached hereto and made a part hereof), whether registered or unregistered and wherever registered (collectively, the "Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by, each of the Trademarks; and (ii) all proceeds, including, without limitation, any claim by Grantor against third parties for past, present or future infringement or dilution of the Trademarks or injury to the goodwill associated with the Trademarks.

This Notice is made, executed and delivered in the State of Connecticut, and it is the specific desire and intention of the parties that it shall in all respects be construed under the laws of the State of Connecticut.


