This Trademark Assignment shall be binding upon the parties, their successors, administrators, and assigns.

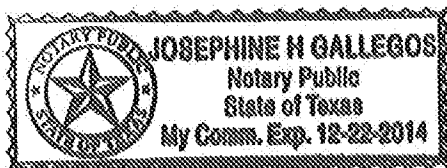


