**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Release") is made effective as of June 26, 2012 by MCG Capital Corporation (the "Administrative Agent") to SXC Health Solutions, Inc., as successor in interest by merger to Systems Xcellence USA, Inc. (the "Grantor"), as follows:

WHEREAS, on December 27, 2002 (the "Original Closing Date"), the Grantor and the Administrative Agent entered into an Intellectual Property Security Agreement (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor granted to the Administrative Agent on behalf of the Lenders, an absolute, present, unconditional, continuing first priority security interest in and to all of the Grantor's right, title and interest, including goodwill related to the trademarks, in, to and under the patents, trademarks and copyrights listed on the attached Schedule A (the "Intellectual Property");

WHEREAS, the Security Agreement was recorded in the United States Patent & Trademark Office on October 21, 2003 at reel/frame 002847/0363; and

WHEREAS, the Administrative Agent wishes to release its security interest in the Intellectual Property listed on Schedule A.

NOW THEREFORE, for valuable consideration, the Administrative Agent hereby releases, without any recourse, statement, representation and warranty, promise or undertaking whatsoever, and at the Grantor's sole cost and expense, all right, title and interest in and to the Intellectual Property, including: (i) its security interest in and lien upon the Intellectual Property; (ii) all goodwill of the business connected with the use of, and symbolized by, each trademark; and (iii) all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (a) infringement or dilution of any Intellectual Property or (b) injury to the goodwill associated with any trademark.
