**RELEASE OF TRADEMARK SECURITY INTEREST**

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made effective as of June 22, 2012 by Citicorp North America, Inc. (the "Agent") to NMHG Oregon, LLC, successor in interest by a series of merger, assignment and conversion filings to YALE Materials Handling Corporation (the "Grantor"), as follows:

WHEREAS, on May 26, 1989 (the "Original Closing Date"), the Grantor and the Agent entered into a Trademark and License Security Agreement (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor granted to the Agent on behalf of the Lenders, among other collateral, a continuing security interest in all of the Grantors' right, title and interest, including goodwill, in, to and under (i) the trademarks, registered trademarks, trademark applications, service marks, registered service marks and service mark applications, including, without limitation, the trademarks, registered trademarks, trademark applications, service marks, registered service marks and service mark applications listed on the attached Schedule A (the "Marks"), and (ii) any license agreements with any other party in connection with any trademarks or such other party's trademarks, registered trademarks and trademark applications, trade names and service marks, including, without limitation, those license agreements listed on the attached Schedule B (the "Licenses");

WHEREAS, the Security Agreement was recorded in the United States Patent & Trademark Office on June 8, 1989 at reel/frame 0654/0519; and

WHEREAS, the Agent wishes to release its security interest in the Marks and the Licenses.

NOW THEREFORE, for valuable consideration, the Agent hereby releases, without any recourse, statement, representation and warranty, promise or undertaking whatsoever, and at the Grantor's sole cost and expense, all right, title and interest in and to the Marks and the Licenses, including: (i) its security interest in and lien upon the Marks and the Licenses; (ii) all goodwill of the business connected with the use of, and symbolized by, each Mark; and (iii) all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (a) infringement or dilution of any Mark or (b) injury to the goodwill associated with any Mark.

IN WITNESS WHEREOF, the Agent has caused this Release to be executed by its duly authorized officer.


