NOTICE OF SECURITY INTEREST IN TRADEMARKS

THIS NOTICE OF SECURITY INTEREST IN TRADEMARKS is made the 15th day of June, 2012 by and between MARQUETTE CAPITAL FUND II, LP, a Delaware limited partnership, in its capacity as collateral agent (in such capacity, the "Collateral Agent") for the Investors (as defined below) and ECLIPSE ADVANTAGE LLC, a Delaware limited liability company (the "Debtor").

The Debtor and the Collateral Agent acknowledge the following:

A. The Debtor owns the trademarks or trademark applications (the "Trademarks") listed on Exhibit A attached hereto, which Trademarks have been granted by, or applications therefor are pending before, the United States Patent and Trademark Office.

B. The Debtor has granted to the Collateral Agent a security interest in the Trademarks on the terms and conditions set forth in that certain Subordinated Security Agreement dated as of June 15, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among the Debtor, certain affiliates of the Debtor and the Collateral Agent, to secure the payment and performance of the Secured Obligations (as defined in the Security Agreement).

C. Pursuant to the Security Agreement, the Debtor has granted to the Collateral Agent a security interest in and to all of the Trademarks and applications therefor, now owned or from time to time after the date hereof owned or acquired by the Debtor, and in and to all proceeds and benefits thereof and does hereby confirm and reaffirm the grant of the security interest in such assets.
