INTELLECTUAL PROPERTY ASSIGNMENT

THIS AGREEMENT is made as of the 18th day of May, 2012 between WESTCOAST TOY LTD., (the "Transferor") and LARSEN & BOWMAN HOLDINGS LTD., (the "Transferee"), each having a business office at #17 – 650 Clyde Avenue, West Vancouver, British Columbia, Canada, V7T 1E2

WHEREAS:


- A. Pursuant to the Court Order and Bill of Sale referred to below (copies of which have been provided to the Transferee), the Transferor acquired the entire right, title, interest and estate of the Assignors (as defined below) in and to following assets (collectively, the "IP Assets"):
- (i) all of the copyrights, domain names, trademarks, patents, trade names, customer lists and other assets described in and/or listed in Exhibit A attached to a certain Trustee's Bill of Sale dated December 16, 2011 made in favour of the Transferor by the Trustee for the estate of the Russ Companies, Inc. et al (collectively, the "Assignors", including without limitation, Russ Berrie U.S. Gift Inc. and The Encore Group, Inc.) pursuant to an Order of the United States Bankruptcy Court, District of New Jersey, Case No.11-22471, dated and filed December 6, 2011 (collectively, the "Intellectual Property"), which Exhibit A is attached to this Intellectual Property Assignment; and
 - (ii) all of the goodwill of the business symbolized by and associated with the Intellectual Property, together with the right to sue or recover and retain damages and costs and attorneys' fees for past, present and future infringement of the Intellectual Property and to entirely stand in the place of the Assignors in all matters related to the Intellectual Property;
- B. The Transferor has agreed to assign and transfer to the Transferee and the Transferee has agreed to acquire from the Transferor all of the right, title, interest and estate of the Transferor in and to the IP Assets.

NOW THEREFORE THIS AGREEMENT WITNESSES that for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The Transferor hereby assigns, transfers and conveys to the Transferee and the Transferee hereby acquires from the Transferor all of the right, title, interest and estate of the Transferor in and to the IP Assets. For greater certainty, the IP Assets are set out in Exhibit A attached hereto.
2. The Transferor represents and warrants to the Transferee that it acquired ownership of the IP Assets pursuant to the Court Order and the Bill of Sale, that it has not subsequently mortgaged or otherwise encumbered any of the IP Assets and that it has the authority to transfer the IP Assets to the Transferee in the manner contemplated hereunder. Except as set out in the immediately preceding sentence, the transfer of the IP Assets hereunder is without representations or warranties of any kind, express or implied, including without limitation, representations of merchantability and/or fitness for any particular purpose.

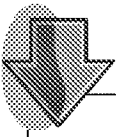

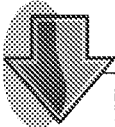

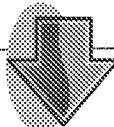
